Approval of "KOHLER" Dual Flush Valves

Your letter dated 22 November 2016 and subsequent submission received by this department on 23 February 2017 refer.

Having considered the test reports ref. 161544ST160537B and 161544ST160537(1)B both issued on 17 February 2017 by Fugro Technical Services Limited, this Authority accepts that the fittings described below comply with, and their use when correctly installed does not contravene, the Waterworks Ordinance and Regulations.

Name of Manufacturer: Kohler China Investment Co Ltd

Details of Fitting:

1. 62mm Dual flush valve
Model: AS IS DUAL FLUSH 1PC
2. 60mm Dual flush valve
Model: AS IS DUAL FLUSH 2PCS

Body Markings: Kohler

Expiry Date: 8 September 2021

Proviso: As the fittings have not been tested for use in contact with water intended for human consumption, the fittings can only be used in flushing water plumbing system.

This Authority hereby permits the use of the above fittings in flushing water plumbing systems subject to full adherence to Waterworks installation requirements. In particular, you are required to draw your customers' attention to the following requirement-

“The flushing volume of the flushing valves should be adjusted to suit the design of the toilet bowl so that wastes can be cleared effectively by a single flush.”

“The maximum flushing cistern volume including that of dual flush cisterns for use in conjunction with the fittings shall not exceed 7.5 litres per flush.”

“The fittings should be used within the range of working pressures specified by the manufacturer.” AND

“The installed fittings should not result in backflow of water that will contaminate the flushing water supply.”

A condition of this acceptance is that the fittings to be installed shall be replicas of the samples as certified by the testing agent mentioned above and without modifications. This acceptance may be withdrawn at any time if the standard of the fittings installed fails to meet that of the approved samples or if the fittings are found to be unsuitable for use in flushing water plumbing systems.

For the use of the fittings in any project, the Acceptance Reference Number at the bottom of this letter must be quoted as a means of identification of acceptance of the fittings by this Authority.
