For the use of the fittings in any project, the Acceptance Reference Number at the bottom of this letter must be quoted as a means of identification of acceptance of the fittings by this Authority.

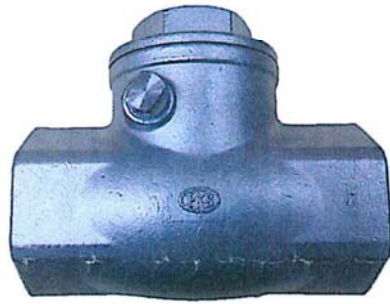
