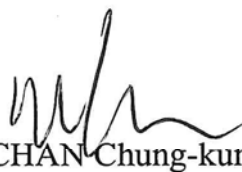
This Authority hereby permits the use of the above fittings in fresh water plumbing systems and fresh water fire services systems subject to full adherence to Waterworks installation requirements.
