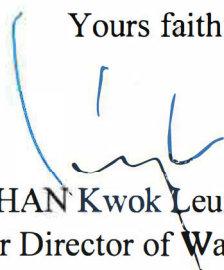

For the use of the fittings in any project, the General Acceptance Number of this letter must be quoted as a means of identification of acceptance of the fittings by this Authority.

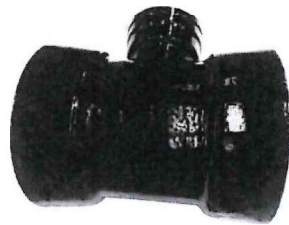
