This Authority hereby permits the use of the above fitting in fresh water plumbing systems subject to full adherence to Waterworks installation requirements. In particular, you are required to draw your customers' attention to the following requirement-

"The cold water supply to the fitting shall be drawn from the same source that supplies the hot water apparatus so as to provide a balanced pressure and to obviate the risk of scalding in the event of a restriction or failure in the water supply." AND

"The shower head or handspray should not be placed in submerged conditions and should be securely fixed to the original position after use."

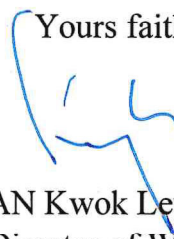
A condition of this acceptance is that the fitting to be installed shall be replicas of the sample as certified by the testing agent mentioned above and without modifications.
